Dear Leader Schumer, Speaker Johnson, Minority Leader McConnell, Minority Leader Jeffries, Chairwoman Murray, Chairwoman Granger, Vice Chair Collins, and Ranking Member DeLauro:

As the second session of the 118<sup>th</sup> Congress begins, the XX undersigned organizations—representing a broad range of health care stakeholder organizations – write to express our overwhelming support for efforts to include the PREEMIE Reauthorization Act (H.R. 3226/S. 1573) and the Preventing Maternal Deaths Reauthorization Act (H.R. 3838/S. 2415) in the final FY 2024 appropriations package or as part of any other must pass legislative package. These critical bills will reauthorize essential maternal and infant health programs and research at a time when maternal and infant death rates, especially in communities of color, have increased dramatically.

Thanks to the support of bipartisan Members of Congress, critical maternal health legislation was enacted over the last Congress. However, our ongoing work to improve maternal and infant health is more important than ever as our nation is in the midst of a dire maternal and infant health crisis. In 2021, preterm birth rates rose to a 15-year high, the maternal mortality rate continued to rise making the U.S. one of the most dangerous places to give birth in the developed world, and there are unacceptable disparities in birth outcomes. In fact, a recent report from Centers for Disease Control and Prevention’s (CDC) National Center for Vital Statistics showed that infant mortality increased by 3% in 2022, marking the first time in more

than two decades the U.S. has seen a year-over-year increase in infant deaths.<sup>1</sup> As a nation, we can and must do better at preventing avoidable maternal and infant deaths.

We collectively look forward to continue working with Congress to address this crisis through bipartisan policies focused on increasing access to quality and equitable health care, supporting healthy moms and babies, and improving research and surveillance. Two pieces of legislation that will be key to doing this are the PREEMIE Reauthorization Act (H.R. 3226/S. 1573) and the Preventing Maternal Deaths Reauthorization Act (H.R. 3838/S. 2415). Both bills have received strong bipartisan support. The PREEMIE Act was unanimously approved by the House Energy & Commerce Committee, passed by the full House of Representatives by voice vote, and was approved by the Senate HELP Committee by voice. The Preventing Maternal Deaths Reauthorization Act was unanimously approved by House Energy & Commerce Committee and reported favorably by a voice vote in the Senate HELP Committee, and is awaiting a vote on the House suspension calendar.

The PREEMIE Reauthorization Act (H.R. 3226/S. 1573) represents the federal government's commitment to preventing preterm birth and its consequences, a leading contributor to infant death. The U.S. has a D+ grade in the March of Dimes Report Card, with a 10.5% preterm birth rate – approximately 383,000 preterm births.<sup>2</sup> Preterm-related causes account for 35.8% of infant deaths, and preterm babies may suffer long-term impacts such as birth defects, intellectual and developmental delays, behavioral problems, neurological disorders, visual and hearing impairments, cerebral palsy, and respiratory or intestinal insufficiency. Not including the loss of thousands of lives, the annual societal economic cost (medical, education, and lost productivity) is an estimated \$25.2B.

The Preventing Maternal Deaths Reauthorization Act (H.R. 3838/S. 2415) would strengthen and expand federal support for Maternal Mortality Review Committees (MMRCs). MMRCs are tasked with identifying maternal deaths, analyzing factors that contributed to those deaths, and translating the lessons into policy changes. The U.S. has one of the highest maternal mortality and morbidity rates in the developed world, with nearly 900 women dying due to pregnancy-related causes in 2020. Passage of this legislation would help provide ongoing support of MMRCs and better protect birthing people throughout their pregnancy, childbirth, and postpartum, and assist in narrowing racial disparities in outcomes.

We ask that you include these bipartisan maternal and infant health bills in the final FY 2024 package or other must-pass legislation this Congress. Lastly, we express our support for strong, sustained investments in our country's maternal and infant health programs, including newborn screening, research and surveillance, maternal mental health, and prevention programs in the FY 2024 budget. Without understanding the root causes and best practices associated with strong, healthy moms and babies, it will be even more difficult to reverse these staggering, deadly outcomes.
